

End User License Agreement for E-SPIR Supplier Software

BY DOWNLOADING, STORING OR USING A COPY OF THIS SOFTWARE YOU AGREE TO THE FOLLOWING TERMS:

1. OWNERSHIP.

The E-SPIR Software is owned by Shell Global Solutions International B.V. (Shell) vested in The Hague, The Netherlands.

2. LICENSE.

(a) Shell grants a temporary, non-exclusive, non-transferable License for E-SPIR Supplier software to all individuals and entities that have a need of preparing and processing spare parts information as required for engineering and materials data handover to Shell Affiliates, Joined Ventures with a Shell interest or to 3rd party entities that have entered into a commercial service agreement with Shell for their licensed use of the E-SPIR Advisor module.

The E-SPIR Supplier End User License includes the right to

(b) download, store, install and use of the Software for above purpose and the purpose of evaluation, testing, training, data migration or support.

(c) upgrade the software to newer versions, as and when they become available from www.e-spir.com.

3. LICENSED TERRITORY.

(a) You may use the software at any location in the world, subject to export control regulations.

(b) The ECCN classification of the E-SPIR Supplier product is: 'Dimin US <10%'.
(c) The software runs on the Microsoft Windows platform with .NET, MSAccess and Excel, which have separate ECCN classifications provided by Microsoft.

4. TERMINATION AND CHANGE OF AGREEMENT.

(a) The End User License expires 3 years after the above authorised business need has ceased.

(b) Shell may terminate your License if you fail to comply with the terms of this Agreement. Such termination shall be confirmed by a written notice, issued from an authorised employee of Shell Global Solutions International B.V.

(c) Shell may change the terms of this Agreement unilaterally, at any time, for any reason, without upfront notification. After change, Licensed Users will be given a grace period of 3 months to either comply with the new terms or accept termination of the License.

(d) After expiration or termination of your End User License you shall remove all copies of the Software and documentation from all your systems and archives. This excludes the E-SPIR databases, Excel exports or reports that hold your data.

5. PRODUCT SUPPORT.

(a) Shell will provide support to licensed users via email and phone, whereby we aim for a reply within 24 hours during normal European business hours. The contact for support is at www.e-spir.com.

(b) Licensed users will be requested to upgrade their installation to the latest version in order to benefit from all fixes and improvements in the software.

(c) The scope of product support is to clarify functional use or help resolve operational problems with the product. This excludes professional services in the area of materials management.

6. CHARGES.

(a) Use of E-SPIR Supplier software is free of charge.

(b) Product support via www.e-spir.com is free of charge.

7. COPYRIGHT AND INTELLECTUAL PROPERTY.

(a) Shell owns all copyright, intellectual property rights in the Software and accompanied documentation.

(b) The Software runs on the Windows computer platform, which copyright and intellectual property is owned by Microsoft.

(c) You may not modify the Software or accompanied data and documentation in any way.

(d) You may not re-publish the software on distribution locations that can be accessed by un-authorised individuals (external to your entity).

(e) You may not sublicense, rent or lease the Software.

(f) The user and entity using the E-SPIR Supplier software are both responsible for compliance with Copyright and Intellectual Property rights of any data entered into the E-SPIR application.

8. WARRANTY.

(a) Shell warrants that the Software will perform substantially for its business purpose and in accordance with the user documentation.

(b) In case defects are found and reported, Shell's product support will make best effort to provide a work-around, provide a software fix in the next release, and assist with data repairs if relevant.

(c) This warranty only applies to the latest version of the Software that can be downloaded from www.e-spir.com

9. LIABILITY.

(a) In no event Shell shall be liable for any type of damage incurred by the licensee, arising out of the use or inability to use the software or any associated documentation, data or services.

(b) Licensees will be liable for compliance of Copyright, Intellectual property, Privacy and Global Export Control legislation specifically related to the data that they load into the tool, the location of use, and the nationality of staff that operate the software.

(c) This Agreement shall be governed by Dutch law. Any disputes arising in connection with this Agreement shall be finally settled by the Netherlands Arbitration Institute (Nederlands Arbitrage Instituut). The arbitral tribunal shall be composed of one arbitrator, the place of arbitration shall be The Hague and the language of the proceedings shall be English.
